1. Introduction

Transparency and openness of institutions to the public is one of the main factors that affects the increase of accountability of institutions but also better performance of the public administration itself. The current system of public consultations established in 2016, has already entered a phase of stability of the policy-making process and drafting of legislation in the Government of the Republic of Kosovo. This process is being led and coordinated by the Office on Good Governance/Office of the Prime Minister and is being supported by the public consultation coordinators in the Office of the Prime Minister, Line Ministries and local level. As a result, the compliance with the standards set by the Regulation no.05 / 2016 on minimum standards for public consultation has already become part of the daily work of government institutions.

The Government of the Republic of Kosovo, through the Office on Good Governance in the Office of the Prime Minister, together with ministries and municipalities have managed to publish on the online platform https://konsultimet.rks-gov.net/ and share with NGOs and the public the documents that have been drafted and submitted for approval to the government and within the ministries. The platform has been a window where the public and NGOs have been provided access to inclusion, information and opportunities to contribute through commenting and recommendations on policies and legislation drafted by public institutions.

The current crisis with the Covid19 pandemic during 2020, which is still ongoing, but also the change of two governments during 2020, have definitely slowed down and greatly complicated the policy-making process and consequently the public consultation, including all the steps and tools for involving CSOs and the public in policy-making, monitoring the drafting of legislation and policies until their approval by the government.

However, despite the situation created by the pandemic and the institutional one, the Office on Good Governance / Office of the Prime Minister together with the coordinators have continued to provide space, by utilizing their maximum capacities, for the public to be involved in the public consultation process. Through the online platform, the Office on Good Governance together with the ministries have managed to publish and share with the public the documents planned to be drafted and continuously forwarded for approval by the government and the ministries.

As of September 2020, the Office on Good Governance / Office of the Prime Minister has upgraded the modalities in the consultation platform and through the platform, website and social networks, it has developed and is developing an information campaign for the Online Public Consultation Platform and Minimum Standards for Inclusion of citizens in policy making and decision making. A guide to using the Online Public Consultation Platform (tutorial) has been prepared which calls on citizens, civil society representatives and the general public to use the Online Public Consultation Platform, but also explains how they can get involved in the platform and comment. This campaign aims to raise public awareness on the importance of effective use of the Online Platform for Public Consultation, on

strengthening, sustainability and stability of the public consultation system and most importantly the inclusion of civil society in policy making and decision making.

In addition, the Office on Good Governance / Office of the Prime Minister, as coordinator of the public consultation process in cooperation with all line ministries through consultation coordinators in the ministries involved in the policy and legislation development process, has worked on monitoring and implementation of standards for public consultation.

Consequently, regarding the monitoring of the implementation of the Minimum Standards for public consultation, the Office on Good Governance / Office of the Prime Minister is working at all times to provide an overview of the implementation of the regulation and standards set for inclusion. Therefore, this document also provides an overview for 2020 regarding the implementation of standards for public consultation.

Monitoring of the implementation of the consultation process is also part of the Government Strategy for Cooperation with Civil Society 2019-2023. It is also part of the evaluation of the European Commission through the agreement of the Government and the European Commission for direct budget support. In addition to the extension to the central level of government, the public consultation system has been extended to all municipalities both in terms of regulation and the creation of tools and conditions for its implementation. However, it should be noted that the local level is not part of the scope of this report this year, because there are only a few municipalities that have begun to publish documents for public consultation and the appointment of coordinators for consultations from the local level is still ongoing. Up to date, there are thirteen (13) coordinators who have been appointed by the local level and only the Municipality of Rahovec, which has published documents for public consultation.

2. Executive Summary

In accordance with Regulation no. 05/2016 on Minimum Standards for Public Consultation, Office on Good Governance/Office of the Prime Minister leads and is responsible for drafting the Annual Report on Public Consultations developed by all ministries and Offices of the Prime Minister. I In accordance with the requirements of the Regulation, The Office on Good Governance / Office of the Prime Minister, in cooperation with all ministries and other institutions involved in the policy and legislation developing processes for the fourth consecutive year has prepared annual reports on public consultation.

Annual report for 2020 will include all documents that have been published on the public consultation platform for which the consultation started on 01.01.2020 and closed on 31.12.2020. The report aims to present the work done during 2020 in the implementation of minimum standards for the public consultation process by the Government and line ministries.

The report presents details and statistics for meeting all standards from planning, initiation and process of drafting documents, course of consultation, drafting of consultation document, use of consultation methods including platform, public participation in providing their contributions, status of comments etc.

The report presents in detail the following categories of information:

- <u>Total number of drafted and consulted documents</u> From the beginning of 2020 until the end of 2020, it is reported that 184 documents were drafted, of which 181 documents were for public consultation on the online platform and three documents were approved by the government and were not published on the consultation platform. 184 documents include: 16 concept documents, 44 draft laws, 2 strategies, 4 programs, 6 action plans, 42 draft regulations and 70 administrative instructions.
- **Compliance with the standards** -Out of 181 (one hundred and eighty-one) documents published on the platform, 115 (one hundred and fifteen) of them comply with the standards and 66 (sixty-six) of these documents do not comply with the standards. The three documents outside of the platform do not meet the standards for consultation.
- <u>Compliance with the SBS indicator criteria</u> The estimate for SBS indicators for compliance with the indicator 2 for public consultation for 2020 has been 75%. However, these goals, during the last year have been postponed to be met in 2021, given that the Covid pandemic19 has affected their non-compliance. However, it is worth mentioning that within the framework of the terms of the SBS indicator during 2020, a total of 66 (sixty-six) documents were consulted. Out of the former,

64 (sixty-four) documents were consulted through the platform: 15 (fifteen) concept documents, 44 (forty-four) draft laws, 3 (three) programs and 2 (two) strategies as well as 2 (two) documents that have been consulted outside of the platform and approved by the government (a concept document and a program). Out of the total 66 (sixty-six) documents: 16 (sixteen) concept documents: 09 (nine) concept documents meet the consultation criteria and 07 (seven) do not meet the criteria, draft laws: out of the total 44 (forty-four) that are on the platform: 29 (twenty-nine) meet the standards and 15 (fifteen) do not meet the consultation standards). The estimate for these statistics is not including government decisions for consulted documents. Out of 4 (four) programs: 1 (one) program meets the consultation standards and 3 (three) do not meet the standards. While 2 (two) strategies do not meet the standards and SBS criteria.

- **Participation in the consultation process and comments** In total 1021 participants are reported to have participated in the public consultation process. A total of 1898 comments were made from these participants either through meetings, working groups or even in writing. It is estimated that 961 comments were fully accepted by the drafters of documents, 463 comments were partially accepted and 474 comments were rejected or not accepted by the drafting institutions.
- <u>Used consultation methods</u> -During 2020, 181 documents were published on the public consultation platform. Three documents were not consulted through the public consultation platform. Out of 181 documents, 98 of them were consulted through official communication and 91 documents were also consulted through working meetings. While 148 documents, according to reports, have received input or have been commented by the public through official communication and the platform.

3. Methodology for reporting and monitoring the implementation of standards

Even in 2020, the annual reporting on the course of public consultations was done according to the reporting methodology for the regulation on public consultations. Several sources of information were used to prepare the report:

- All data and information provided by the coordinators of public consultations from each ministry and the Office of the Prime Minister.
- Data published and updated by the public consultation platform.
- Other data derived from the activities of the Office on Good Governance/Office of the Prime Minister and projects that support the Government in developing and advancing public consultation.

The request of the Office on Good Governance/Office of the Prime Minister for reporting by the ministries, sent on 22 February 2021, was responded by 13 out of 16 ministries and the Office of the Prime Minister.

The Ministry of Communities and Return MCR does not have documents published on the public consultation platform, while the MFAD and the MIA have not responded to the request for reporting. The data for these ministries were obtained directly from the platform administrator. In addition to these documents, the Office of the President of the Republic of Kosovo has published one document on the platform for public consultation and the Municipality of Rahovec has published five documents on the platform for public consultation. Nevertheless, these data for the Presidency and the Municipality of Rahovec are not included in this report.

Reporting by the coordinators was done through the forms, designed to collect information for the drafting of the annual report according to the Regulation and Monitoring and Reporting Methodology on implementing the minimum standards approved by the OPM in 2017.

Similarly, since some of the information reported by the ministries did not match what is found on the platform and the ministries mentioned above did not report at all, then additional information was obtained from the electronic platform for public consultation.

The assessment criteria pursuant to the Regulation on Minimal Standards are:

- Each consulted document shall have the consultation plan.
- The consultation document together with the principal document being consulted shall be published in the public consultations' electronic platform.
- The consultation deadline shall be at least 15 work days.

- The consultation report shall be published in the platform for each consulted document.
- The principal document of the consultation shall be published after the inclusion of comments and proposals.




Figure 1. Graphic presentation of statistics by central institutions

4. Online platform for public consultations /https://konsultimet.rks-gov.net/

During 2020, the Office on Good Governance within the Office of the Prime Minister, on the online platform for public consultation, has worked on updating the data for institutions and coordinators throughout the pandemic, as well as amending the decisions of the Assembly for government institutions, correcting the platform and its maintenance with new data.

A guide to using the Online Public Consultation Platform (tutorial) has been prepared which calls on citizens, civil society representatives and the general public to use the Online Public Consultation Platform, but also explains how they can get involved in the platform and comment.

OGG/OPM has continued to work on building a public consultation system at the local level and to accommodate requests for the inclusion of municipalities in the consultation process. During 2020, new modules for each municipality have been added to the platform and a statistics generation system was built for the local level as well. The Office on Good Governance within the Office of the Prime Minister has made updates of data for institutions and coordinators throughout the pandemic and amended the decisions of the Assembly for government institutions on the online platform for public consultation.

5. Cooperation and capacity building for public consultation for public officials

During 2020, the Office on Good Governance/Office of the Prime Minister has continued to cooperate with ministries and civil society in terms of the smooth running and improvement of the public consultation process. Ministries, but also Municipalities, have been provided with ongoing support by the Office on Good Governance through daily information, responses and clarifications as requested by them.

During 2020 Office on Good Governance/Office of the Prime Minister, in cooperation with the Kosovo Institute for Public Administration and with the support of the EU TA project, have organized and provided the Training of Trainers (ToT) Program for public consultations. This program is offered to public institution officials and aimed to create a group of trainers that will be engaged in the future by KIPA as capacity building trainers for other officials in public institutions in the field of public consultation.

In September 2020, the Office on Good Governance/Office of the Prime Minister in cooperation with the Kosovo Institute for Public Administration, following the evaluation procedures by the Commission, organized a ceremony for the award of ToT certificates for public consultation. On this occasion, 10 (ten) Trainers for public consultations were certified.

In this way, the sustainability of capacity building activities undertaken in previous years with the support of the EU technical assistance project will be ensured. Furthermore, the implementation of the ToT program will provide additional impetus to meeting the indicators of Sector Budget Assistance for public administration in Kosovo.

6. Coordination and progress of the consultation process within the institutions

Internal coordination and cooperation, within the ministries, is seen as a major challenge in terms of the smooth running of the public consultation process.

The coordinators expressed their continuous concern regarding the lack of coordination within the institution in the ministries. On 1 December 2020, the Office on Good Governance/Office of the Prime Minister with the support of the OSCE conducted a workshop with coordinators for public consultation in line ministries. On 09-10 December 2020, OGG/OPM has organized the Workshop "You also participate" Public consultations and all-inclusiveness - improvement of the decision-making process for policies and legislation. The purpose of the workshop was to discuss with Civil Society Organizations: the importance of all-inclusiveness and consultation with the public, the role of civil society in the consultation process and the opportunities for civil society to be involved in policy-making and legislation.

In order to further improve access to the consultation process and the online platform for public consultation, the Office on Good Governance/Office of the Prime Minister with the support of the OSCE, on 01 December 2020 conducted a joint online workshop with the Coordinators for consultation, while on 09 and 10 December 2020, it conducted a two-day online workshop with Non-Governmental Organizations.

The Office on Good Governance/Office of the Prime Minister is conducting an information campaign for the Public Consultation Platform. A guide and promotional video have been prepared for the use of the Online Platform for Public Consultation, which is on the platform and social networks. On 14-15 December 2020, OGG/OPM in cooperation with KIPA conducted a training for civil servants from the central and local level for public consultation and the online platform for involvement in policy making.

7. Total number of draft documents

During January-December 2020, the Government of the Republic of Kosovo has finalized the consultation for 181 documents, which fall into the category of documents that according to the Regulation, their drafters are obliged to consult with the public (figure 4).




Figure 2: Number of documents consulted (2020)

Out of these documents, 181 were published on the consultation platform, while three documents were consulted only through other methods of consultation.




Figure 3: Number of documents by categories (2020)

• The largest number of documents which were drafted during 2020 belong to the category of bylaws. From the beginning of 2020 to the end of 2020, it is reported that 184 documents have

been drafted, of which 181 documents have been for public consultation on the online platform and three documents that have been approved by the government and which have not been on the consultation platform. Out of these 16 concept documents, 44 draft laws, 2 strategies, 4 programs, 6 action plans, 42 draft regulations and 70 administrative instructions.

8. Level of compliance with the minimum standards

The number of documents which have undergone public consultation is almost 100%. Compliance with the minimum standards of the public consultation process expressed in percentage during 2020 is: 64.09% of the documents comply with the standards and 35.91% do not comply with the consultation standards.




Figure 4: Level of compliance with the standards

- The Ministries that have fully complied with the standards are: The Ministry of Defence, the Ministry of Local Government, the Ministry of Trade and Industry and the Ministry of Justice.
- The ministries without a single document for public consultation during 2020 were the Ministry of Communities and Return.

09. Methods used during the consultation process

According to information reported by the ministries and the Office of the Prime Minister and those obtained from the Electronic Platform for Public Consultation, during 2020 181 documents were published on the platform and three were not published. In addition to the publication on the platform, it was reported that a total of 1,021 participants participated in the public consultation process. A total of 1898 comments were made from these participants either through meetings, working groups or even in writing.


10. Number and status of comments

During 2020, 181 documents were published on the public consultation platform. Three

documents were not consulted through the public consultation platform.

It is estimated that 961 comments were fully accepted by the drafters, 463 comments were partially accepted and 474 comments were rejected or not accepted by the drafting institutions.

Out of these, 98 documents were consulted through official communication and 91 documents were consulted through working meetings. According to the reports, out of 181 documents, 148 documents have received inputs or comments by the public through the platform. A total of 1898 comments were made either through meetings, working groups or even in writing. It is estimated that 961 comments were fully accepted by the drafters, 463 comments were partially accepted and 474 comments were rejected or not accepted by the drafting institutions.








Figure 6: Division of documents by comments on the platform




Figure 7: Comments by ministries

The public consultation platform in the current version can only generate the number of commenters and the number of documents which have been commented through the platform but not the number of comments. Many of the comments on the platform are provided through attached documents which in a document contain a greater number of comments than those automatically generated in the statistics section. While the number of comments calculated in this report is based on official information provided by the coordinators of public consultations in the ministry (figure 7).

The chart above reflects the comparative information by ministries on the number of documents consulted, the number of participants and the number of comments. It is worth noting that public participation in the consultation process according to the data varies from ministry to ministry.

The volume of activities of the ministries for the consultation process during 2020 definitely differs from the previous year. Given the time of the pandemic and the impossibility of holding meetings and workshops with CSOs and the public, the main goal of the institutions during 2020 has been to inform the public and CSOs as much as possible about the documents that are being drafted and involve them in the drafting and consultation process. This is done so as to ensure the increase of the number of documents that meet the standards and improvement of the quality of consultations.

<u>Consultation quality</u> - this year, too, the methodology used to draft this report and the resources allocated does not provide the opportunity to assess the compliance with the standards from the

quality standpoint. However, according to the information provided through reporting, and those published, some good examples of ministries that have published and consulted documents on the platform during 2020 can be singled out: Ministry of Defence, Ministry of Local Government, Ministry of Trade and Industry and Ministry of Justice.

11. Challenges during 2020 - There are always challenges in the process along the way, starting from the technical ones to the non-compliance with the institutional obligations regarding their implementation. A challenge that should be mentioned in the implementation of the regulation and compliance of the institutional obligations is the failure to timely report and publish final reports on the course of public consultations for a document which has been published on the platform. This is because the regulation does not set a deadline for the publication of the report. Another challenge during the process is also the non-involvement of organizations and the public through directly commenting on the platform for published documents.

During 2020, the following challenges have been identified:

- Change of governments within a year,
- Covid19 pandemic
- Movements of staff and coordinators from one ministry to another
- Restructuring the number of ministries and coordinators from 22 ministries to 12 and then 16.

12. Recommendations - The current system of public consultations is already at a stage of stability of the policy-making process and drafting of legislation in the Government of the Republic of Kosovo. Therefore, this is a significant step forward in improving standards for citizen and civil society participation in policy-making and decision-making.

The steps to be taken for this purpose include the following:

- Increased work engagement with the management of the ministries but also with the other staff responsible for the development of consultations, in order to increase their understanding of the importance of implementing the quality of minimum standards for public consultations.
- Continuation of activities for capacity building of ministries and information on the system and rules of public consultations.
- Offices within the Office of the Prime Minister should assume the responsibility they have with the regulation on minimum standards for not allowing their approval in the Government if the documents do not meet the minimum standards.
- The public consultation process, challenges and problems should be regularly discussed in the Meetings of the Secretaries General.
